This release of liability shall include, without limitation, any claims of negligence or breach of warranty and is intended to cover all claims that members of the participant's family or estate, heirs, representatives or assigns may have. I further agree to indemnify, hold harmless and defend Camp Happy, HAPPYfeat.org of Georgia, LLC, and all contributing partners, leadership members, directors, independent contractors, volunteers, partner employees and agents from and against any and all claims or other causes of actions related in any way to my participant's participation in such activities. It is my understanding that participating in the programs and recreational and other activities, including special events of any of the above organizations which are managed by Happy Feat, LLC, is a privilege.

Prior to my participant's participation in such activities, I acknowledge that there are certain risks associated with such activities, including without limitation, physical injury due to activity-related accidents, physical injury due to accidents, illness or even death.
